DELEGATION Richard Reimer discussed the use of shipping containers on his property for storage purposes, stating that he was unaware that the containers were against the bylaws of the Village.


DELEGATION Stephanie Michelson made a presentation to Council regarding the success of the recent triathlon held in Stirling. She thanked the Village for the contributions that were made.


2010-132 Councillor Selk moved to accept accounts payable #20102191 & #20102307. Mayor Nilsson abstained. Carried
