Fire Chief Thomas Hodder discussed with Council the recent fire call in the Village where the Raymond Detachment was called in to assist. Hodder indicated this prompted a review of the fee and rates charged for call outs by the Stirling Department. He recommended new rates for Schedule "D" of Fire Bylaw 422. Hodder also asked Council to review the Penalty rates listed in Schedule "E".

Council asked Fire Chief Hodder to bring recommendation and comparisons back to Council.
