And whereas the Board of Directors of Ridge Country Housing gas authorized the securing of long term debt financing to support the Ridgeview Lodge project in combination with majority funding obtained through the Government of Alberta.

Therefore, be it resolved that Council does approve in principle the use of debt financing by the Housing Authority to move the project forward subject to the condition that any such borrowing shall not impact or otherwise affect the debt service limit or borrowing capacity of the municipality.
