NELSON FAMILY
RANCHES WATER
METER EXEMPTION

Council discussed the Nelson Family Ranches request to be exempt from the installation of water meters in each residence.

Mayor Nilsson moved:

Be It Resolved that the Village of Stirling will replace the one water meter in the 4th Avenue and 8th Street manhole, at the cost of the Nelson Family Ranches water users, in order to capture water flow to the residences along downstream rural water line. The applicable fees for water usage for the rural users will be charged to each residence along that line plus the usual charge for water consumed.

Be It Further Resolved that the Village of Stirling reserves the right, for any reason, to place further meters along that water line or within the residences serviced by that water line. This right is reserved for the purpose of maintaining efficiencies within our water metering system. If it is deemed necessary to place further meters along said water line, the cost to do so will be charged to the residences along that water line.
