# STIRLING WIND PROJECT

Councillor Lewington moved Whereas the Village of Stirling is a member of the SouthGrow Regional Initiative and thereby the Southern Alberta Alternative Energy Partnership (SAAEP) which strives to ensure communities are "investment ready" for renewable energy related projects.

Whereas the proposed Stirling Wind Project will likely provide positive benefits to the broader region including lease revenues for area land owners, incremental tax revenues for Counties in the region as well as contribute economic activity to southern Alberta.

And, whereas Stirling Wind Project LP and its partners appear to have addressed relevant environmental, public safety, aesthetic and operational concerns.

But, whereas potential negative impacts to residents of the Village itself still need to be addressed.

Therefore, be it resolved that the Council of the Village of Stirling provides its conditional support for the project contingent on Stirling Wind Project LP actively seeking to ensure the

employment of local residents, engagement of local contractors and businesses as well as maintain an active, ongoing involvement in the Village with specific measurable outcomes.

And further be it resolved that Council authorize the Mayor to send written correspondence to Stirling Wind LP advising them of this motion and requesting the opportunity for a meeting to better understand the project impacts on the community.
