

The Village of Stirling Council meeting held at the Stirling Community Centre on October 17, 2018. In attendance: Mayor Trevor Lewington, Councillors Robert Edwards, Matthew Foss, Kevin Nelson and Larry Nilsson, CAO Mike Selk and Administrative Assistant Aletta Lightfoot.

CALLED TO ORDER

Mayor Lewington called the meeting to order at 7:17 p.m.

DELEGATION(S)

Fire Chief Rob Fisher and Captain Marv Birky presented the Fire Department 3rd Quarter Report, including:

- Organizational restructuring to represent a clearly defined command structure operating on any emergency scene.
 Changes include two Deputy Chiefs, three Captains (each with an area of responsibility in Operations, Training and Truck), a Non Denominational Chaplain, and two Lieutenants.
- The Department has gained seven new members: one Junior and six Firefighter Recruits.
- The Department has gained five new auxiliary members who will be responsible for fundraising, grant applications, providing support on fire scenes and support for training events.
- Have downsized vehicle fleet by eliminating the White Ambulance and Pickup Truck.
- Commercial Vehicle Inspection Reports will be once every three years instead of annually. Motor Vehicles fewer than 1,300 kg do not require a CVI and will be inspected annually by one of two mechanics currently on the Department.
- Currently have nine fully qualified NFPA 1001
 Professional Firefighters. Training course for NFPA 1001
 Firefighter Level 1 course started October 15 and all new and existing Firefighters who are not certified will be in

this program.

- Due to cost of new personal protective gear
 (approximately \$1,900 per set), only fully trained members
 to NFPA 1001 Level 2 will be provided new structural gear
 protection. Members that are going through training will
 be provided Wildland/Extrication gear (approximate cost
 is \$650 per set).
- List of specific equipment purchased over the past six months for vehicle extraction, traffic incident equipment and structure fire items.

	STREET LIGHTING	Administration presented background information on the LED streetlight upgrade with Fortis and the follow up conversation and action with Fortis.

Councillor Foss discussed the LED streetlight upgrade undertaken in Raymond and the cost and agreement with Fortis including:

- Within the agreement with Fortis, the Town of Raymond added 80 light fixtures for a cost \$2,600. Project value was approximately \$150,000 in capital costs. Ongoing operational costs would also be incurred.
- The Village of Stirling currently has approximately 115 streetlight fixtures. If adding additional streetlights Council would need to consider possible infrastructure upgrades including new pole installation and ongoing operational costs.

PROJECT – UPDATE

Administration updated Council on the Solar Net Zero project including:

- Solar installation at the Community Centre, FCSS Building, Fire Department and shop yard building are now complete and will be online shortly.
- The ground mount system will be installed next month.
- Changes to the solar grant program will mean lower lease payment for all projects including a onetime capital cost rebate at the ground mount site of approximately \$80,000.

SOUTH GROW – BROADBAND RESEARCH PROJECT

Administration presented information about the South Grow Broadband project. South Grow is looking for support its Regional Initiative application to the CARES program to fund the project Alberta Rural Broadband Development: A Cost Benefit-Analysis. In cooperation with other partners, this is to produce a reputable and academically rigorous research study that draws defensible conclusions regarding a cost-benefit analysis of rural broadband deployments within the province of Alberta.

- Chief Mountain Solid Waste Authority purchased a new loader for the cost of \$275,000 moving funds from the depreciation/replacement account.
- Fencing is underway at the Transfer Station in effort to mitigate/reduce the amount of garbage being blown onto adjacent properties. Cost will be covered by the Authority as most of the materials to be used are already on-hand.

Mayor Lewington reported:

- Four Mayors Meeting concentrated on the Cannabis Legislation and ICF negotiations.
- Schedule meetings with Raymond prior to ICF negotiations with the County to have common perspective.
- South Grow will be hiring someone specifically for grant writing, and it will be funded through South Grow.

Councillor Nelson reported:

- Ridge Water Commission: carbon filter installation to be completed soon.
- Water Commission was chosen for the operation contract at Writing-On-Stone Provincial Park. A revenue for the Commission.
