Cancellation of Annual Settler Days events due to COVID-19

Closure of the Stirling Pool for the 2020 Season due to COVID-19

MOVED by Mayor Lewington that in consideration of public safety and to ensure appropriate social distancing in compliance with public health orders issued by Alberta's Chief Medical Officer of Health that all non-essential activities related to the preparation and opening of the Stirling be cancelled. Further move that the Stirling Pool remain closed for the 2020 summer season and that only essential maintenance or system protection related activities proceed.
