Lots 5-8, Block 41, Plan 752J - Assessment Review: Adam Depew presenting:

- Reviewed the timeline of his property, from purchase in August 2018 to present
- Concerned with previous taxes: why does property have two separate roll numbers?
- Went to the office to consolidate the properties where it was discovered that the two roll numbers shared the same LINC number
- Reviewed the 2019 and 2020 taxes notices and property assessments sent out by the Village and compared them with numbers he had calculated as if the properties were one, and not two
- 2020 property assessment has been revised by Benchmark Assessments and both properties are now under one roll number and one LINC number
- Requesting a refund of \$525.95 for the 2019 year

Mayor Lewington presented:

- Administration went through files and found that the land originally had been under one roll number and one LINC number in 1984
- For unknown reasons, two LINC numbers were created in 2007 (perhaps for future consolidation?), but was never completed


