The last few weeks have seen many lively debates in parliaments, workplaces and living rooms across the country. Emotions have run high as our nation grapples with fundamental questions about freedoms, rights and corresponding responsibilities. My hope is that people become much more involved in the democratic and government processes that impact their daily lives. It takes time to cut through the seemingly endless misinformation now available through social media. It takes time to do the research and understand the legislation that governs our land. It is time well spent. I think part of the reason that I am such a big believer in the local or municipal level of government is that discussions at Council are less driven by partisan polictics and more focussed on finding solutions to problems in our community. any adjustments that may be needed. We continue to focus our financial resources this year on the reopening of the pool and continued progress on our ongoing multi-year road rehabilitation program.

I attend a regular monthly meeting of roughly 40 mayors and reeves from across southwest Alberta. February's monthly meeting with my peers was focussed on ambulance availability and emergency medical services (EMS) dispatch in our region. Alberta's Health Minister as well as the Chief Paramedic of Alberta attended our meeting virtually to provide an update on the Government of Alberta's 10 point plan to improve service. I am grateful that the highly trained and dedicated professionals of Stirling's Fire Department provide a medical first response program to bridge the gap while waiting for ambulances to arrive to calls in our community. Medical first response or MFR is a critical service when every second counts and ambulances must sometimes come from Lethbridge or Coaldale.
