Administration would like to recognize members of the Stirling Fire Department for their efforts to save a life. Two paramedics from Raymond, Chris Pilling and Christian Mora received an Excellence in Resuscitation Coin from Alberta Health Services. Captured below is the message, which was sent to Administration from Fire Captain Brant Tidmarsh, who is also an AHS Paramedic as these two paramedics wished to share this success with our fire members who were a large reason this award was received:

"Last year, on February 13, our department responded to cardiac arrest for a 56 year old male who collapsed. Stirling Fire department (Assistant Chief Higginson, Fire Fighter Cooper, Fire Fighter Evans, Deputy Chief Birky, and Captain Steciw) administered CPR and the patient was transported to the hospital. Two of our members (DC Birky and Cap. Steciw) rode in the ambulance and performed CPR. Cardiac arrest calls are always reviewed by managers and the medical directors and it was determined the CPR that was done was considered excellent. In their report they determined that the accuracy was 90% and the rate of compressions was 112 (goal is 100-120). After 8 shocks and high quality CPR, the patient unfortunately passed but because of the combined effort of EMS and our firefighters, we were able to provide the patient his best chance of survival. The medics wanted to let you know the reward they received was because of the department's efforts and they are grateful for all your hard work."

Council extends congratulations to Brant Tidmarsh on his recent promotion to Captain of Platoon B with the Stirling Fire Department.
