**A BY-LAW OF THE VILLAGE OF STIRLING IN THE PROVINCE OF ALBERTA
FOR THE PURPOSE OF ESTABLISHING FEES, RATES AND CHARGES FOR MUNICIPAL
SERVICES IN THE VILLAGE OF STIRLING**

WHEREAS, the Municipal Government Act RSA 2000, Chapter M-26, as amended or repealed and replaced from time to time, authorizes the Council of a municipality to pass bylaws

- (a) For municipal purposes respecting services provided by or on behalf of the municipality, and,
- (b) For the establishment of fees for licenses, permits and approvals:

AND WHEREAS the Municipal Government Act RSA 2000, Chapter M-26 provides for the provision of municipal utility services subject to the terms, costs or charges established by Council:

NOW THEREFORE the Council of the Village of Stirling, in the Province of Alberta, duly assembled, thereby enacts as follows:

1. This Bylaw may be cited as the 2025 Fees and Charges Bylaw.

DEFINITIONS

2. In this Bylaw, the following words mean:

- a) "Administrator" means the Chief Administrative Officer of the Village of Stirling.
- b) "Council" means the Municipal Council of the Village of Stirling.
- c) "Village" means the Municipal Corporation of the Village of Stirling.

PROVISIONS

3. The fees and charges payable for municipal services provided by the Village of Stirling shall be as outlined in Schedule A, which is attached to and forms part of the Bylaw.

REPEALS

4. This bylaw repeals Bylaw 542-23 Fees Rates and Charges Bylaw upon third and final reading.

This bylaw shall become effective upon the third and final reading.

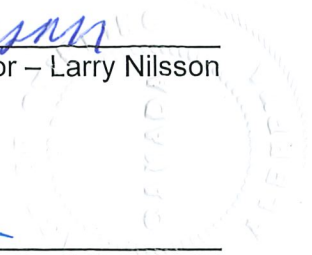
