- 4.1 Honourable Grant Hunter, MLA Taber-Warner

Hon. MLA Hunter asked if there were any upcoming changes that would impact Stirling?

- Local Government Fiscal Framework (LGFF) formula
  - waiting on budget (deliberations in March)
  - o in 2024 Stirling received approximately \$288,00.000 in LGFF funding
  - smaller municipalities don't necessarily have the same accessible tools that larger communities have access to
- Provincial Policing Cost
  - Federal government negotiated a 39% increase in police wages, leaving the provinces (and therefore, the municipalities) to pay for it
    - Communities under 5,000 are responsible for paying that cost

Hon. MLA Hunter briefly spoke on a few high points over the 2024 year:

- Three key pieces of Alberta legislation passed in 2024:
- 1. Education Act
  - o parents need to be involved and authorize pronoun requests for their children
- 2. Health

- puberty Blockers
  - age of consent (adult decisions)
- 3. Only biological females are allowed to compete in women's sports Alberta Advantage measures?
  - December 2024
    - o Added 35,000 jobs in Alberta
    - o 40% of Canada's private sector jobs were created in Alberta

### Premier Smith

- New tax bracket (saving Albertans over \$600/year)
  - o stay tuned!

The Barons-Eureka-Warner - Family & Community Support Services (BEW-FCSS) Needs Assessment Project, led by the Prentice Institute at the University of Lethbridge, is a 23-month initiative (June 2024 – March 2026) to evaluate community needs and assets across the 16 municipalities in the BEW region. The project aims to improve municipal service delivery by identifying gaps, understanding well-being needs, and providing data for planning and budgeting in alignment with Alberta's Provincial Prevention Priorities: homelessness, family and sexual violence, employment, mental health, and aging in communities.

Currently in the data collection phase, the project seeks broader participation in interviews and focus groups, especially from elected officials, municipal employees, and service providers. Key outputs include municipal needs and priorities reports, asset inventories, survey reports, and focus group results. The findings will support informed decision-making, shared services, and a collective focus on preventing social challenges.
