4.2 DA10-25 Add use Restaurant with parking waiver - parking waiver to use of Retail Store Limited

Conditions

- 1. Add use restaurant and retail store limited as per application DA10-25.
- All public health certificates, or any other certificates required to operate a food based business shall be required.
- 3. Any signage being undertaken for the restaurant or retail store limited businesses shall be required to adhere to Part Seven of Land Use Bylaw 549-24.
- Any signage requiring a permit will be required to be done prior to the implementation of the sign.
- A parking waiver is hereby granted by agreement with the Village for both access sides of the business' location.
- 6. Grease is not permitted to be drained into the sanitary system and any grease shall have to be managed by the applicant through an alternate party.
